A. OBITUARY The Members of the Committee stood to remember **Mr Derek Sullivan**, a former Management Committee man who, amongst other roles, managed the League Representative team.

B. OBITUARY Post meeting, Ickwell & Old Warden reported the death of **Mr Peter Bygraves** who died on 13th October 2021. Peter was 88 and had been unwell for some time. Known to many as "Mr Ickwell", Peter will always be associated with Ickwell & Old Warden FC where he served as Secretary for over 60 years until June 2019 at which time the Club were pleased that he accepted the position of President. 4. FINANCE

- ❖ Alan Young, as League Treasurer, reported on current balances of the League Accounts, referring also to the need for new online banking arrangements.
- ❖ The Treasurer reported on the invoices raised by the General Secretary for outstanding pre-season payments, with three-figure debts from **St. John's Luton** [£114.10] and **Sundon Park Rangers** [377.90] still unpaid. The debts are now passed to all registered players for these Clubs at the end of season 2020-2021.
- ❖ The Treasurer reported on all the other invoices for September and October, including Luton Park pitch bookings. It is very important that Clubs pay for their Luton Park pitches by the deadline shown on the league invoice. NOTE: PARK PITCH PAYMENTS COVERED BY RULE 6[I] and FINES AND COSTS COVERED BY RULE 6[J] [shown as 6[H] and 6[I] in revision 1 online]
- ❖ **RULE 6[I]** A Club must comply with an order or instruction of the Management Committee and must attend to the business and/or the correspondence of the Competition to the satisfaction of the Management Committee. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
- ❖ **RULE 6[J]** Subject to a Club's right of appeal in accordance with Rule 7 below, all fines and charges must be paid within 14 days of the date of notification of the decision. Any Club failing to do so will be fined in accordance with the Fines Tariff. Further failure to pay the fine including the additional fine within a further 14 days will result in fixtures being withdrawn until such time as the outstanding fines are paid.

- ❖ Mr Young left the meeting at this point, after raising one item of Any Other Business.

In response to a League request to investigate, Bedfordshire FA replied that the player's registration was approved on 20th August 2021 but there have been several issues where the system deactivates a registration the same day it has been approved.
