- ❖ Issued on Monday 12th October 2020 for being in breach of league rule 18N
 - **Kempston Athletic.** In having in their game against Langford Reserves on Saturday 10th October played one Seb McConchie registered under fan 57706876 being the same person as Sebastain McLouchie already registered under fan no 6670005 with Sandy FC for the 2020-21 season. Game Drew 0-0. Club replied by email Monday 12th October denying charge with documentation.
 - Whilst accepting the name of the registered player with Sandy FC player is incorrectly spelt, the Committee decided that Kempston Athletic had not applied sufficient due diligence in making this registration.
 - Charge found proved
 - Registration with Kempston Athletic cancelled. Should the player wish to join Kempston Athletic then a transfer will be needed.
 - **Match point [1] gained by Kempston Athletic deleted. One [1] addition penalty point deducted.**

 - Match points [three in total: 1+2] awarded to Langford Reserves, score to remain 0-0.

 - **Shefford Town & Campton Reserves** : In having in their game played on Saturday 10th October 2020 against Bedford Albion played one Dean Gray whose name does not appear on their teamsheet (substitute) exchanged with Bedford Albion and the match day referee prior to kick off. Game lost 2-0. Verbal reply received from club. "clerical error by manager when filling in teamsheet exchanged with the referee and Bedford Albion. Entered name of Dean Harvey (no such player but a family member) confirm Dean Gray a correctly registered player took part in the game and entered as such on our Full Time result sheet " (Referee failed to keep record of the substitutes which would have prevented this happening)
 - Charge proved, but Club explanation accepted and referee failure noted.

 - The error affects SML and not BCFL [no breach of BCFL rule]

- ❖ Checked out at the request of AFC Kempston Town & Bedford College Reserves the eligibility of a **Stotfold Development** player in their game played on Saturday 3rd October 2020. Findings being no breach of rules, a simple case of a spelling error on the exchanged teamsheet. (Player named as Ethan Park, known as Parks, correct name Ethan Parker, only Ethan registered by club, played in their previous weeks fixture } Club requested league stance on spelling mistakes on teamsheets. Club informed each case is treated on its own individual merits.
- ❖ **AFC Kempston Town & Bedford College:** Reported 20th October 2020 registration of Anas Bechkourn has disappeared from Whole Game & Full Time. Issue passed onwards to support team at Beds FA. Problem resolved by re-registration of player 21st October 2020.
- ❖ **Blunham:** 17th October 2020. Noted that their player Lee Crouch registration is spelt incorrect as Lee Coruch. Advised to contact support team at Beds FA to amend who would require photo evidence before doing so. (matter still outstanding)
- ❖ **Flitwick Town:** Reported 17th October 2020. Transfer of Warren Bell from Lea Sports PSG has successfully transacted for their 1st and 2nd teams but not gone through for their A team. Issue passed onwards to support team at Beds FA. Reply received 22nd October 2020 matter now resolved. (or at least will be when Flitwick Town register the player on WGS attaching him to their A team))
- ❖ **Stevington:** Email sent 23rd October 2020 seeking clarification of registration of Colm McGill Fan no 56067542. Appears to be same player has Colm McGill Fan number 61682757 registered with Bedford Albion before his transfer to Brickhill Wanderers. Club replied 24th October 2020 stating same person. With the original Bedford Albion registration being made first, the Stevington registration made in the incorrect name has been cancelled.
- ❖ **Sundon Park Rangers.** Emailed the league to inform Caldecote Reserves had listed on their teamsheet and played one Liam Peel against them on Saturday 31st October 2020 who does not appear on their list of registered players. (Game won by Sundon Park Rangers). Player registered being in the name of Liam Brady Peel.
