1. PREVIOUS MEETING

- ❖ The minutes of the Management Committee meeting held on 4th April 2019 were signed as a true record.

2. MATTERS ARISING

- ❖ **Hy-Pro footballs** - there are reported cases of these match balls splitting. General Secretary met with Hy-Pro, who will return the two balls provided to the manufacturers for their assessment of the problem. Matter on going. General Secretary to meet with Hy-Pro later this month to review the sponsorship deal for season 2019-2020.
- ❖ **Harlington Juniors** : Represents by Phil Tomlinson – **plea of mitigation**. The Committee acknowledged it was a Club error in playing the player in the semi-final tie, who was ineligible because he had played insufficient qualifying matches, even though he represented the Club in the Quarter Final tie. Whilst the Club expected to meet the Committee prior to the Final Tie being played, it was explained that, as the Club had accepted the charge, the standard punishment is to remove the team from the Competition. No mitigating evidence would alter that decision.

11. NATIONAL LEAGUE SYSTEM including FACILITIES

- ❖ **GROUND GRADING [FACILITY CHECKS]** of ALL Premier Division Club and potential promotion candidates will be carried out during the close season, and FULL COMPLIANCE with the minimum requirements must be met. There can now be no discretion applied and Clubs not meeting the requirements will be relegated from the Premier Division at the end of season 2019-2020.

- ❖ Proposals for season 2020-2021:
- **Neutral Assistant Referees** will be employed in the Premier Division in season 2020-2021. This will be introduced gradually over the 2019-2020 season.
- **Team Shelters** will be mandatory. The League will supply these on loan [subject to conditions].
- **Pitch barriers** will be required on all four sides of the pitch, preferably permanent rail, complete or partial.
- Duralock Pitch Barrier Systems – simple post and rail barrier for complete pitch surround circa £5K.
- ❖ **Elstow Abbey FC**: Further to recent discussions within the club's committee concerning ground development and minimum area for changing room requirements, we would like to begin to consider making internal alterations to extend these areas and to widen the refreshment room. In this regard we would ask the Beds County League Committee, if possible, to provide support funding for the provision of a recommended architect to begin the initial stage for this project at Elstow. The Committee agreed to support the Club when presented with a firm proposal and cost.
