## 17. LEAGUE DEVELOPMENT PLAN REVIEW

- ❖ Thursday 13th February 2020 @ 14:30 at Hertfordshire FA – Messrs Snelson, Watson and Simmonds attended together with Beds FA representative Jose Gomes. The Members gave a report on what was a positive review of the Development Plan.
- ❖ **FAIR PLAY AWARDS 2020-2021:** Next season, the League will again be operating a Fair Play Table based upon the number of penalty points levied by a County FA [as detailed in WGS] divided by the number of matches played during the period to give an average mark. The periods will be:
  - **Season start to end of January, February to the end of the season.**
