- ❖ **CONCLUSION: From the extremely poor level of certain Club Administration, as confirmed by the amount of non-conformances detailed above, and the large number of matches awarded instead of played, many Clubs did not take the Supplementary Competitions seriously. The amount of work involved in staging the Supplementaries puts in doubt the staging of any similar competitions in future seasons.**
