1. PREVIOUS MEETING

- ❖ The minutes of the Management Committee meeting held on 3rd November 2022 were agreed for signature as a true record.

2. MATTERS ARISING

- ▶ **3rd October 2022: Biggleswade United Reserves** in breach of League Rule 18M in that in their games played on Saturday 24th September 2022 and 1st October 2022 they played one James Tizard who at the time was under an all football league suspension imposed by the Hertfordshire FA from 11th September 2022. (both games lost)
 - Suspension successfully appealed by the Player, and rescinded. Matter closed, no further action.
- ▶ **7th October 2022 : Atletico Europa** in breach of league rule 18M in that in their opening three games of the season (all lost) they had played one Albert Adeyini who at the time of the games was under a 5 year suspension which runs until September 2023 imposed by The London FA. under the name of Albert Adeyemi.
 - Beds FA found their charge proved with action taken against Club and Player.
 - Club allowed to present their case to the Committee on Thursday 5th January 2023 prior to any league actions.

- ❖ **Whole Game System**
- ❖ Again experienced major problems with registrations not going through from WGS into Full Time during the month with numerous registrations failing to go through into Full Time. The worst being the weekend of 12th November 2022 when the unsorted list rose to nine players. Other flaws highlighted during the month which failed to give warning of double registrations.
 - Bedford Wanderers opened a new fan for player Eran Rifat using a different address from that used in his original fan with Revivalists.
 - FC Polina (Luton) registered Reubean Morrisison under his original fan 59391544 whilst he had previously been registered in correctly by Stopsley United under a new fan but with different address details.
 - In both cases, transfers were applied before either player/ club breached any league rules. However, both instances could have been avoided if the joining club had asked the player the simple question **“Have you already played in the Bedfordshire County Football this season or adult football in the past?”** A ‘yes’ answer would tell the Club the player should already have a fan in the WGS system which they needed to use to apply his registration/ transfer.
- ❖ **Other Matters**
 - Email notice sent out on Wednesday 23rd November 2022 chasing upload of Full Time Results Sheets still not uploaded for their Bedfordshire FA County Cup ties played on Saturday 22nd October 2022. **AFC Bedford United. FC Haynes. Sharnbrook Reserves and Wilstead.**
 - **AFC Bedford United** replied to advise they have been in contact with the Bedfordshire FA since the week of the game taking place without the matter yet being resolved why they cannot access the link to load their result sheet. Details of their player match statistics given and placed on file for player qualification purposes for our 2022-23 season league cups.
 - **FC Haynes** replied to advise that they raised the matter with the Bedfordshire FA on November 3rd 2022 that they could not access the link to load their said result sheet. And that matter is still yet to be resolved and that they would chase them again. Details of their player match day statistics given and placed on file for player qualification purposes for our 2022-23 season league cups.
 - No replies received from **Sharnbrook Reserves or Wilstead.**
 - Email received from **Shefford Town & Campton** to inform that a player from FC Haynes was sent off in their match against Westoning Recreation on 29th October 2022 and that FC Haynes had not included his red card on their loaded Full Time result sheet. Having checked the issued league statement reports for the next two weeks following the game, no record found of any red cards from the game recorded. Requested Richard Horswell to seek clarification from the referee (Jamie Bishop).
 - Referee replied that he had sent in all his reports to the Bedfordshire FA. Bedfordshire FA confirmed no information had been loaded from this fixture to date. Matter continuing with Bedfordshire FA.

11. NATIONAL LEAGUE SYSTEM including FACILITIES

- ❖ Request from **AFC Oakley** for facility grant to extend pitch barriers. A provisional grant of £1000 was agreed subject to conditions. Matter continuing.
- ❖ The initiative to provide each Premier Division Club with Team Shelters, whilst successful in the early days, is proving expensive as the shelters are being damaged by the weather. Further investigation is needed to source alternatives.
