OBITUARY

- ❖ **Dennis Martin.** *It is with sadness to have to report that Dennis Martin, Life Member of Bedfordshire FA, passed away on Tuesday 7th February. He joined Bedfordshire FA in 1977 and was an active member for many years, and was also a former Referees Secretary of the Bedford & District Football League (now Bedfordshire County Football League) before standing down from the role in 2004 and being made a Life Vice-President of the league.  - Online Player Registration season 2017-2018 – ‘drop-in’ workshop to help Clubs with the new online process, which the league wishes to adopt, and suggested Bedford College as an initial venue. Mr Ingerson to progress this possibility. Dates need to be passed on to Nick Snelson Beds FA who will attend help Clubs. Additional information from The FA:
 - 1) There will be at least one roadshow on Whole Game taking place in each county during the months of April -May which will open to all leagues and clubs to attend.
 - 2) There will be around 20-30 Webinars which clubs can join during the months of May-June to see the registration process.
 - 3) The Whole Game team is more than willing if any league give the full green light for season 2017-18 to attend any meeting the league may set up with it's clubs.
 - 4) The Whole Game live system for 2017-18 season for first time users will open up on 3rd July 2017.
 - Initial workshop to be arranged towards the end of the season; *possible venue Bedford College on either a Tuesday or Thursday, start time 6.30pm ending 8.30pm.*

- ❖ Adult only Referee Course. No applications for Saturday referees, therefore the funding offer from the league is withdrawn for this season.
