Charge sheet issued to Bedford Albion Reserves by email on Monday 8th January 2018. Match result 1-1 draw. Bedford Albion Reserves replied by email on Monday 8th January 2018 requesting committee consider their comments of mitigation when making their decision.
 - Charge proved. Match points [3] awarded to **Wootton Village**, score 0-0.
 - Bedford Albion Reserves deducted the point won in the match plus an additional penalty point.
 - Bedford Albion Reserves fined as per rule, **see item 15 below, reference 2018.02-15**
 - **Crawley Green Reserves**: In breach of league rule 8[O] in having played Telmo Jesus in their game against Stevington on 2nd December 2017 whilst he was serving an all football suspension imposed by the Beds FA. Bedfordshire FA charged the Club and found the charge proved [Friday 12th January 2018]. Report/charge notice issued by the League to the club by email Tuesday 16th January 2018. Game won 3-2. Crawley Green replied to charge on Friday 19th January 2018 to request a personal hearing before committee. Club informed hearing would be heard at 8pm on Thursday 1st February 2018, and duly attended.
 - Club represented by Messrs Sherlock and Clark. Dan Gauntlett declared an interest in the proceedings and withdrew from the discussion and decision. Following the hearing, the following were decided:
 - Charge proved. Match points [3] awarded to **Stevington**, score 0-0.
 - Crawley Green Reserves deducted the points [3] won in the match plus an additional penalty point.
 - No fine was imposed, **see item 15 below, reference 2018.02-16**
 - **Henlow** : Subject to Bedfordshire FA charge in having on Saturday 13th January 2018 played Attila Balazi in their game at Totternhoe Reserves [lost 2-1] whilst still under Beds FA suspension. **N.B. Henlow's submitted result sheet to Full Time does not show Attila Balazi having taken part in this game but the player was cautioned by the referee.**
 - Awaiting outcome of Bedfordshire FA's action. Matter continuing.
 - **Renhold United Reserves** : To consider their protest and complaint received on Monday 15th January 2018 that their game on Saturday 13th January 2018 against Houghton Athletic had not been played in accordance with the rules and laws of the game and that Houghton Athletic had played an ineligible player. Match result Houghton Athletic won 2-1. Renhold United Reserves currently subject to a Beds FA charge in having played Nathan France in this game whilst still under Beds FA suspension.
 - Awaiting outcome of Bedfordshire FA's action. Matter continuing.
 - **Shefford Town & Campton A**: In breach of Cup Rule 3B in having included in their Watson Shield game against Bedford Albion Reserves on Saturday 20 January 2018 (game won 5-2) Josh Lummis who had on Saturday 28th October 2017 played in their Reserves Bedfordshire FA Intermediate Cup tie against Sporting Lewsey Park . Charge notice issued to club by email on Monday 22nd January 2018.
 - Charge proved. Shefford Town & Campton 'A' eliminated from the competition with **Bedford Albion Reserves** reinstated.
 - Shefford Town & Campton 'A' fined as per rule, **see item 15 below, reference 2018.02-17**
 - **The 61 FC Luton Reserves** : In breach of Cup Rules 3B and 12 plus League Rule 11C in that the following discrepancies appear between their teamsheet and loaded Full Time result sheet for their Centenary Cup match against AFC Kempston Town & Bedford College Reserves on Saturday 20th January 2017. Match result The 61FC [Luton] Reserves won 3-2. Four players appearing on their result sheet but not on their teamsheet including Jack Stephen who was also ineligible having already this season played in the Bedfordshire FA Senior Trophy. With four players included on their teamsheet who do not appear on their result sheet. Two of those players being registered with another club for season 2017-18 in the BCFL, another player being unregistered at the time of the game and the fourth player confirmed by the match referee as having been a used substitute. Charge notice issued to club by email on Tuesday 23rd January 2018.
 - Charge proved. The 61FC [Luton] Reserves eliminated from the competition with **AFC Kempston Town & Bedford College Reserves** reinstated.
 - The 61FC [Luton] Reserves fined as per rule, **see item 15 below, reference 2018.02-18**

11. NATIONAL LEAGUE SYSTEM including FACILITIES

- **Clubs requesting grant aid from the League MUST provide written cost estimates of the project BEFORE any work starts, as there is no guarantee that a League Grant will be made.**
- ❖ **Marston Shelton Rovers** – redevelopment continues at a very slow pace. Bedfordshire FA advise that a start date is no further forward because there is still a shortfall in the funding requiring grant applications to be made; the drawings, whilst thought to have been completed, need updating to include finishing's and services; confirmation that approval of planning permission has not been confirmed, though permission was given to the original design and little has changed externally; and because of the delay in completing the drawings, firm build estimates have not been requested. All of the above have to be put in place first and **requires the football club** and playing field committee to complete the FSIF and Sport England applications. Whilst the delays with drawings and estimates are frustrating, there is no reason why the applications and

paperwork couldn't be pieced together so that everything runs smoothly **but that is where the football club haven't been proactive at all**. Relegation from the Premier Division at the end of this season is a distinct possibility for the Club.

- ❖ **Crawley Green** – Beds FA awaiting a report from the Regional Pitch Advisor. The goalposts are reported as being in a poor state requiring replacement. Facility inspection overdue.

13. CHARTER STANDARD LEAGUE

- ❖ Additional funding request made to The FA, who have confirmed receipt and will process the request. League will be informed of when any grant may be made.
- ❖ It was reported that there are still Clubs who have either lost, or not yet gained, their Charter Standard status, putting them at risk of not only losing valuable league and FA benefits, but also their registration with the League. Clubs not listed here are all ready Charter Standard Club and are congratulated on retaining or achieving this status. Since the last meeting, **Houghton Athletic** have been awarded their Charter Standard, with The 61FC [Luton] moving to 'in progress'.
