 - ▶ **3rd October 2022: Biggleswade United Reserves** in breach of League Rule 18M in that in their games played on Saturday 24th September 2022 and 1st October 2022 they played one James Tizard who at the time was under an all football league suspension imposed by the Hertfordshire FA. 182 days from 11th September 2022. (both games lost)

 - ▶ **7th October 2022 : Atletico Europa** in breach of league rule 18M in that in their opening three games of the season (all lost) they had played one Albert Adeyini who at the time of the games was under a 5 year suspension which runs until September 2023 imposed by The London FA. under the name of Albert Adeyemi.

► **Whole Game System [WGS]**

- ❖ **Sporting Carpathians** were of the belief that the registration made by **St Joseph's** (Saturday), who they were due to play that afternoon in a Bedfordshire FA Intermediate Cup tie, of Garvin Brown (new FAN 74572744) was a fictitious person and that **St Joseph's** were planning to play one Garvin Watson who they understood to be under suspension.
 - **St Joseph's** were made aware of **Sporting Carpathians** claim, but St. Joseph's said the player had been recommended to the club earlier in the week and his details given to the Club for registration by another player.
 - The outcome of an investigation being, that having spoken to the said person he admitted he was indeed Garvin Watson but sometimes played under the name of Garvin Brown.
 - On Monday Garvin Watson was registered with the BCFL by **Sporting Carpathians** under his FAN 542174, used for several seasons, which showed completely different personal data than that submitted under the Garvin Brown new fan.
 - **The Committee decided this to be a deliberate attempt to play under an assumed name, and the registration of Garvin Watson be withdrawn for the remainder of season 2022-2023.**
- ❖ **Player Tyla McCabe** [Fan 6520669] registered with **Barton Rovers Reserves** but already registered by **The 61 FC Reserves** under the full name of Tyla Aaron McCabe [Fan 74318754]. A check clearly showed these to be the same person. WGS is not preventing dual registrations, or even offering data for checking. **Clearly, when registering a player, a Club must ascertain if the player has played previously in England as this would indicate an existing FAN and should prevent dual registrations.**
- **Other Matters**
- ❖ **FC Haynes Reserves v Sporting Carpathians Reserves:** Possible discrepancies between players on exchanged Team Sheets and those entered on Full Time. An investigation by the League concluded no breach of rule had been committed by either team.
 - **Explanations accepted – result [3-1 Haynes] to stand.**
- ❖ **Stotfold Junior v FC Haynes Reserves:** Haynes informed the League they had incorrectly entered on Full Time players Toby Lancaster as Toby Lawrence.
 - **Explanation accepted – result [0-0] to stand.**

11. NATIONAL LEAGUE SYSTEM including FACILITIES

- ❖ Request from **AFC Oakley** for facility grant to extend pitch barriers. A provisional grant of £1000 was agreed subject to conditions. Matter continuing.
- ❖ The initiative to provide each Premier Division Club with Team Shelters, whilst successful in the early days, is proving expensive as the shelters are being damaged by the weather. Further investigation is needed to source alternatives.
