This was done without agreement between the two teams and with no extenuating factors to warrant the shortened fixture. Referee referred to the Bedfordshire FA for development. Match to be rearranged, with original fixture declared void. **League to pay both pitch and referee fees for the rearranged match.**
  - **League rule 20A:** ... All Competition Matches outside of the NLS shall have duration of 90 minutes unless a shorter time [not less than sixty [60] minutes] is mutually arranged by the two Clubs in consultation with the referee prior to the commencement of the match, and in any event shall be of equal halves ...
- ❖ **Referee Coverage** at 99.09% in October (1 fixture without appointed official). Much worse in November – 88% & 82% for the first two weeks. Rest of the month looks to be stronger in comparison.

❖ Issued by email on Tuesday 15th October 2019 club in breach of league rule 18N/21c :

- **Bedford Santos:** Having named on their teamsheet and played one Michael Sikorski in their game with Revivalists FC on Saturday 12th October 2019 ( game won 4-1. texted as one of their goalscorers by their chairman on Sunday 13th October at 11.44am) who at the time of the game was not a registered member of the club and then replaced him on their Full Time result sheet by Teyon Kanden Robert Wilfried who does not appear on their teamsheet exchanged with the match day referee and Revivalists FC prior to kick off. Further charged with playing one Mousse Mohammed Jibril as a substitute who again does not appear on their teamsheet exchanged with the match day referee and Revivalists prior to kick off. **Club replied by email 21st October 2019 accepting charge with comments in mitigation why their result sheet differs from their teamsheet.**
  - **Charge proved.** Match awarded to **Revivalist FC**, score 0-0.
  - **Bedford Santos** deducted the Match Points [3] gained from this match plus a further three [3] Match Points.
  - Club fined as per rule, **see item 15 below, references 2019.11-46**

❖ Charge issued by email on Sunday 27th October 2019 club in breach of league rules 18N/21c:

- **Bedford Santos:** Having in their game against Sandy Reserves on Saturday 19th October 2019 played one Moses Gilson who at the time of the game was not a registered member of their club. Game won 3-2. Club not replying to charge within the required 7 days. Club email again Monday 4th November 2019.
  - **Bedford Santos FC to be represented by Club Secretary and Team Manager at the League Management Committee meeting to be held on Thursday 5th December 2019. General Secretary to confirm details with Club.**

❖ Charge issued by email on Tuesday 5th November club in breach of league rule 18N

- **The 61 FC Luton Reserves:** Having in their game against Houghton Athletic on Saturday 2nd November played four classified first team players whilst the rule only allows for the maximum of three just players. Match won 2-1.

### ❖ Other Matters

- ❖ **28th September 2019. Beds FA Junior Cup 1st Round :** Beds FA informed by email on Monday 30th September 2019 that **Blunham FC** have used an unregistered player ( Daniel Whitten ) in their game played on Saturday 28th September 2019 against Revivalists. Game won 17-2. **Action taken by Bedfordshire FA:** Blunham removed from Cup and Revivalists reinstated.
- ❖ **12th October 2019. St Joseph (Saturday) v Sundon Park Rovers** Division Two Saturday 5th October 2019.
  - Email received from Sundon Park Rovers claiming the St. Joseph's teamsheet exchanged prior to kick off differed with the loaded Full Time Result Sheet. Having investigated the matter with the match day referee and St Joseph's it was decided that no breach of playing rules had been undertaken. Sundon Park Rovers informed of by email on 15th October 2019. Result sheet amended accordingly. Sundon Park Rovers unable to accept the result of the investigation and requested the matter goes before the next committee meeting for decision.
  - Having heard the evidence from the investigation, the Committee accepted the explanation from St. Joseph's. No further action.
