- ▶ **Bedford SA:** In breach of league rules 18F/18M in that they have registered one Joey Russo on the 14th October 2021 under Fan Number 63006537, being the same player as one Joseph Russo already registered on the 8th October 2021 for the 2021-22 season with The 61 FC Luton Reserves under Fan Number 68284174.
 - Decision: based upon detailed evidence, the registration of the player Joseph [Joey] Russo, who knowingly registered for two Clubs at the same time, is suspended for the remainder of the season.
 - The registration of the player remains with The 61FC [Luton] Reserves.
 - All Bedford SA matches involving Joseph Russo to be awarded to the opponents, where applicable.
 - The resulting loss of points to Bedford SA [a possible 16] to be limited to 12, as per rule, with 6 applicable immediately and 6 suspended to the end of the season, to be applied at the discretion of the Management Committee when reviewing a similar situation.
 - No fines levied on Bedford SA.
- ▶ **Marston Shelton Rovers Reserves**, being in breach of league rule 18M that in their game against Sporting Carpathians on Saturday 18th September 2021 they played Carl Borromeo who at the time of the game was under Bedfordshire FA suspension. Game won 4-3. Charge issued following the belated notice received from the Bedfordshire FA by email the previous day.
 - **Marston Shelton Rovers Reserves** fined as per rule **see item 15 below, reference 2022.02-21 and deducted one [1] match point.**
 - Match points [3] awarded to **Sporting Carpathians**, score 0-0.
- ▶ **Kempston Rovers [BCFL]**, being in breach of league rules 18M/21C in that in their game against FC Polonia (Luton) on Saturday 8th January 2022 they named on their teamsheet and included on their Full Time result sheet one Matthew Barrett who took no part in the game, his place being taken by Harvey Eagle who is not registered with Kempston Rovers (BCFL) for season 2021.22. Game won 6-2.

Plus have played him in their games under this false information on [a] Saturday 11th September 2021 against Brache Phoenix (won 3-0); [b] on Thursday 30th September 2021 against Potton United Reserves (lost 3-7) Beds FA Intermediate Cup) and [c] on Saturday 16th October 2021 against Renhold (lost 1-3).
