- ❖ Resulting from last month's visit to the Management Committee meeting by Messrs Young and Desborough from Bedfordshire FA, who provided facts and figures relating to the referee marks for the current season, and offered one possible reason affecting the availability of good young referees, that is the need to give them the opportunity to referee in teams of three. This is not a current option in the BCFL, and it was suggested, not only by the Bedfordshire FA representatives, that **the introduction of Neutral Assistant Referees on Premier Division matches should be seriously considered for season 2018-2019**. It was appreciated that this would add to the financial burden of all Premier Clubs, but the League continues to make efforts to reduce this burden and would look to the Clubs to examine new ways to generate additional funds to cover these costs. **Action:** General Secretary to canvass the opinions of Premier Division Clubs.
